(1) The Department of Housing and Community Development is expected to be the conduit issuer of Infrastructure Bonds for the following jurisdictions:

Charlestown, Cumberland, Middletown, St. Mary's Metropolitan Commission and Taneytown.

(2) These issuances are expected to be refunding of bonds and notes currently outstanding.

(3) MWQRLF = Maryland Water Quality Revolving Loan Fund. The Maryland Water Quality Financing Administration provides loans to local

governments for wastewater and drinking water treatment facilities using revenue bonds and other fund sources.

(4) \$1.5 million to mature in 1 year

(5) Included on a prior Anticipated Debt Report but the financing did not close during the previous reporting period.

(6) Talbot County's portion of the Chesapeake College Bonds, to be borrowed by Queen Anne's County and Talbot County will pay debt service to Queen Anne's County.

(7) Funding is anticipated to be through the National Rural Water Loan fund with the purpose of painting the inside of the town's water tower.
